
COLLECTOR'S RETURN OF UNPAID TAXES

That after diligent efforts to collect said taxes, we have been unable to collect some and they are and remain unpaid.





RE: FINAL TAX COLLECTOR'S REPORT 2017-2018

Attached is the Final Tax Collector's Report for the 2017 levy. The approved tax levy was \$20,728,563.57. The initial STAR exemptions tallied \$2,214,435.00 thereby netting \$18,514,128.57 to be collected. Tax corrections of \$46,701.28 were deducted from the levy thereby leaving an adjusted tax warrant of \$18,467,427.29.

The District, with the assistance of JP Morgan Chase collected \$17,057,549.67 or 92.33% of the taxes due.

We collected \$25,393.75 in penalty fees.

The remaining \$1,415,877.62 was turned over to the counties to be collected.
