Each location will receive two data cables and a ceiling mounted wireless access point as an extension of the district's current wireless system.

The district's instructional technology plan requires the district's building to have adequate network capacity for students to access educational resources. The use of student owned devices and school supplied devices has increased to the point that the network's wireless capacity needs to be increased to account for the additional devices. Data room improvements are also required to increase bandwidth between data rooms by installing an upgraded backbone, providing uninterruptable power supplies and upgraded power service, and cable management. This will account for the increase of capacity on the wireless network and provide emergency power for all PoE devices such as classroom phones.

The district currently has access point in every other classroom so to account for the increased number of devices per classroom, an access point will be provided in the remaining classrooms. This will provide the additional per classroom capacity as well as the flexibility to load balance the clients connected to the district's network wirelessly.

The smart schools bond act funds will be used to upgrade the district's IP camera system with enhanced features as well as add additional IP cameras to each building. The IP camera system will provide better access to the system by administration as well as allow the the next generation of high megapixel IP cameras. The district has approximately 100 existing IP cameras that will be utilized by the new system and used until the end of their useful life. The new IP cameras will require new data cabling ti each location and in some exterior cases, a surge suppression device as well. The elementary school main entrances will also be upgraded to have the district's standardized secured entrance. The standard utilizes an intercom at the front entrance to address the visitor from the exterior of the building. Once access is given from the main office, the visitor can enter the main office only through a new door in the vestibule. This will funnel all visitor traffic through the main office where they will check in and be documented. The scope of SSBA will be the construction of the secured entrance including new doors, access control, intercoms and wiring.
