SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. OCSD will employ a Director of Facilities/Maintenance/Transportation. This person will serve as the districts Safety & Systems Coordinator, making sure our facilities are in compliance with the most recent CDC Guidance.

Additionally, we will employ an additional custodian to further assist with cleaning and disintection protocols.

Lastly, we are working toward improvements/ipgrades to our HVAC controls systems. In order to improve efficiency in how heating, cooling and fresh air are delivered to the classroomiand office spaces at Riverside Elementary School, OCSD with undertake a project to consolidate the controls under one modern, upgraded system. At a time when controlling indoor air quality is of paramount importance, upgrading and consolidating controls will allow the maintenance personnel simple, quick access from remote locations any time of day. Additionally system upgrades will allow for 24 from monitoring and recording of changes in the system and specific programming of more components, ensuring a safe and comfortable environment for the students and staff.

OCSD will continue to use the RTL process and provide AIS to those students who are identified. K: 12 benchamark assessments in EUA and Math will be given to all students in September/October. Extra classroom support will be given to Tier Linterventions beginning on the first day of school. School's Child Study Teams will meet to analyze classroom progress monitoring data weekly and assess the benchmark data to identify the needs for Tier H interventions.

Grades 9-12 (summer school) High school level courses were offered for credit recovery to those students who were not successful during hybrid/remote learning

ATS Teachers in core subjects will be added at the Middle and High School levels.

A Currequium Coordinator will assist with implementation of evidence based interventions and provide coaching to instructional staff.

To address the growing mental health needs of students, ARP funding will be used to add an additional psychologist and social worker. With this addition, there will be a dedicated psychologist for each district building, which will provide greater accessibility for students.

Licensed Teaching Assistants will be added to each Kindergarten classroom to assist the teacher as many of these incoming Kindergarten students have experienced adverse conditions and were not provided the opportunity to attend a Fre-Kindergarten-program.

OCSD will reserve funding to provide a remote learning option through BOCES for those students who are unable to attend in person due to medical conditions as determined by a doctor.
