This device will allow the staff and students to create digital portfolios of their work by saving digital copies of their work over their entire Middle School and High School career. These devices will be stored in the Main Network Operations Center. This location was refurbished in the last five years including primary power, backup power, and environmental control. In addition, these two devices will replace two older devices. There will be no impact on the power demands or the HVAC services in the NOC.
